**Humane Trap Loan Agreement**

PACT Humane Society hereby agrees to lend equipment/materials to the person identified below for the purpose of feral cat Trap-Neuter-Return.

By signing this agreement, I, the Borrower of the equipment/materials itemized below, agree that:

1. I will not leave this trap outside unattended at any time.
2. When not in use, I will store the trap in a safe, secure place.
3. I will not loan or give the trap to any third party, excluding the PACT-approved or PACT-recommended veterinary hospital (hereinafter referred to as "Veterinary Facility") at the time of service.
4. I will use this trap exclusively for the purpose of Trap-Neuter-Return. I will not use the trap to capture unwanted cats for release/abandonment elsewhere.
5. Under no circumstances will I surrender trapped cats to law enforcement authorities, animal control authorities or facilities, or any third party other than the Veterinary Facility at the time of service.
6. I will not, and will not allow others, to attempt to handle or touch any feral, stray or unknown cat(s) in connection with the use of this trap, except the Veterinary Facility.
7. I will return cats to their original environment after they recover from veterinary services, unless a relocation site has been approved in writing by a PACT Management Team member.
8. I will forfeit my deposit for each item that is not returned in satisfactory condition, defined as:
  - a. The equipment/materials will be returned in the same condition as received by the Borrower.
  - b. Trap(s) and cat-a-combs will be thoroughly scrubbed clean and disinfected on all sides prior to return to PACT.
  - c. Videotapes & their protective cases and PACT Manuals will be kept clean and free of stains, food particles and debris.
9. I will forfeit my deposit for each item that is lost, stolen, or damaged, or not returned in satisfactory condition within 14 calendar days of this signed agreement.
10. PACT will refund my deposit in full when borrowed materials/equipment are returned in satisfactory condition within 14 days of this agreement, at PETSMART Schaumburg/Woodfield on Sundays between 12-3 p.m.

I hereby agree to hold PACT Humane Society, its trustees, directors, officers, volunteers, agents, and assigns harmless and to release said entities from any and all liability and/or responsibility for any injury, claim, damage, expense, or loss to the person or property of the undersigned, his or her estate, heirs, agents or assigns, in connection with the use of this equipment.
